

The School District of Hilbert is projecting a tax levy decrease for 2018-2019 of \$86,125 as compared to the district levy for 2017-2018.

Why the levy decrease in 2018-2019 compared to 2017-2018?

- The referendum to "exceed the state imposed revenue limits" by \$400,000 a year for 3 years (approved in April, 2015) is complete, so that is no longer levied for starting this school year.
- At this time, our state aid is unknown, so this may change the levy amount.
 In relation to past year's, our state aid should be higher.




